

Resolution No. 2023-

RESOLUTION AUTHORIZING LINE ITEM TRANSFERS
PURSUANT TO N.J.S.A. 40A:14-78.9

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, submitted an annual budget to the voters of Fire District No. 1 on February 19, 2022; and

WHEREAS, said voters approved the budget as presented and the amount of revenue to be raised through taxation; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, has operated pursuant to and in accordance with said budget through November 1, 2022; and

WHEREAS, commencing November 1, 2022, the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, finds it necessary to expend amounts in excess of those appropriations specified in various line items of the operating appropriation section of the aforementioned budget for fiscal year 2022; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, finds there is excess appropriations in certain line items; and

WHEREAS, N.J.S.A. 40A:14-78.9 permits the transfer of excess funds appropriated for designated line items to line items with insufficient appropriations during the last two (2) months of the fiscal year; and

WHEREAS, N.J.S.A. 40A:14-78.9 requires that the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, adopt a resolution by not less than a two thirds (2/3) vote of the full membership to transfer the amount of the excess line items to those line items where appropriations are deemed to be insufficient.

NOW, THEREFORE, BE IT RESOLVED, that for the above set forth reasons, the transfer of appropriations be made as set forth on SCHEDULE A attached hereto; and

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED, that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board bylaws, borough ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the District Auditor, Robert D. Elliott, C.P.A., of the firm of Mohel, Elliott, Bauer & Gass, for the Board of Fire Commissioners of Fire District No. 1, Borough of Manasquan, County of Monmouth, State of New Jersey, for the purpose of making the appropriate adjustments in the audit for the 2022 fiscal year; and

BE IT FURTHER RESOLVED, that the above set forth transfers be effective December 31, 2022.

SCHEDULE A

- Insufficient appropriations in line item(s) designated “Cost of Operations and Maintenance: Repairs and Maintenance” and “Operating Appropriations Offset with Revenues: Other Expenses-USFA”; and
- Excess appropriations in line item(s) designated “Cost of Operations and Maintenance: Bureau of Fire Prevention” and “Operating Appropriations Offset with Revenues: Salaries and Wages”; and
- The following transfers of appropriations be made:
 - (a) Ten thousand dollars (\$10,000.00) be transferred from line item designated “Cost of Operations and Maintenance: Bureau of Fire Prevention” and re-designated “Cost of Operations and Maintenance: Repairs and Maintenance”; and
 - (b) Four thousand dollars (\$4,000.00) be transferred from line item designated “Operating Appropriations Offset with Revenues: Salaries and Wages” and re-designated “Operating Appropriations Offset with Revenues: Other Expenses-USFA”.
